5. Margin Requirements

The Client is responsible for maintaining sufficient margin. Failure to meet margin requirements may result in automatic liquidation of positions without prior notice.

6. Fees and Charges

Applicable fees include spreads, commissions, swaps, rollover charges, and administrative fees. Fee schedules are published on the Company website and may be amended from time to time.

7. Client Representations

The Client represents and warrants that all information provided is accurate and that the Client has the legal capacity to enter into this Agreement.

8. Termination

Either party may terminate this Agreement by written notice. Immediate termination may occur in the event of breach, fraud, suspicious activity, or regulatory obligation.

9. Governing Law

This Agreement is governed by and construed in accordance with the laws of Ireland. Irish courts shall have exclusive jurisdiction.
